## STILL WAITING FOR THAT PC-ENTERPRISES ORDER?

Sorry that we didn't get this info in time to alert you before Santa made those Christmas orders, but after several members called us, we felt it was time for a newsletter announcement as to why some orders have taken so long to process from our friends in New Jersey, while others arrive in less than a week.

The difference is how you pay for your order. We were told that when PC Enterprises receives your check, they wait 14 days to make sure the check clears before processing your order. If this order is a repair or upgrade, the work does not begin until after this 2-week date, so your order may take up to a month to process. A credit card order or one paid by money order is processed immediately. This policy is stated in the PC Enterprises catalog on page 60, but still, it caused a few problems with Santa's delivery.

So, the way to get your order processed pronto is to order on a major credit card, or pay by either a money order or a cashier's check. These orders are processed "normally the day they are received." And, they are! If you must pay with either a personal check or a company check, PC Enterprises suggests that if you need your order processed quickly, supply them with a credit card number and authorize them to use that account number in case there is a problem with the check. This way, your order will be turned around quickly and everyone will be happy!

## "TIPPYS" From Other Newsletters

### Tip From the *Jr Newsletter*:

You can move the screen image left or right manually with the Ctrl-Alt-Left Arrow and Ctrl-Alt-Right Arrow keys. If you want to automate this, put the following in your AUTOEXEC.BAT file to switch to 80 column mode and move the image two characters to the right.

```
MODE C08,R
```

To move the left use

```
MODE C08,L.
```

Of course, the DOS MODE.COM program must be on your boot disk. (And, yes, just MODE C8 works, also.)

### Tip From *The Phoenix*:

COMSPEC.COM (on Club disk U- 611, Junior Power Pack) is an essential part of a Junior that has more than 128K of RAM. With it you can copy COMMAND.COM to the virtual "C:" drive and force DOS to look there for it. This lets you use the A: and B: drives for program and data files without the need for them being initialized with "FORMAT /S". The result is that you won't see the annoying "Insert COMMAND.COM . . ." message anymore. Add these 3 lines to your AUTOEXEC.BAT file:

```
SET COMSPEC=C:\COMMAND.COM
COMSPEC C:\COMMAND.COM
COPY COMMAND.COM C:
```

**Another Tip from *The Phoenix*:**

Is Your Break Off? Do you often get stuck in a program only to find that the combinations of <Ctrl> <Break>, <Esc>, <Ctrl> <Q>, etc. doesn't do a thing? Well, maybe it's as simple as one more line for your CONFIG.SYS file. Try adding the line "BREAK=ON". When BREAK is on, DOS checks every time it performs a function to see if you have pressed the break keys. Otherwise, it only checks when working with screen, printer, keyboard, or serial port.

**Tip From the *Fox Tails*:**

And one last tip from an old copy of *FOX TAILS* for all you lucky folks who got a hard drive for Christmas: When you begin playing around with the CONFIG.SYS file remember that you can lock up the computer at boot up time. Then you're stuck, because every time you boot (or try to edit) you'll be locked out. Remember to make an "Emergency Boot Disk" when you've loaded DOS.

Simply put a clean disk in the floppy drive and type:

```
FORMAT (DRIVE?) /S
```

where (drive?) is the floppy drive you put the disk into (i.e. A: or B:). The /S will copy the system files and COMMAND.COM to the floppy and make it bootable. The author of this tip states they include a small AUTOEXEC. BAT file which sets the PATH to C:\DOS and to their utilities (for easier editing). It pays to copy to this disk the files you feel you would like to have, such as XCOPY, FORMAT, QEDIT, SYS.COM (in case you need to re-format the C: drive or to reinstall DOS), and a few other useful tools like Norton Disk Doctor.

**And, The Tip 'o the Day:**

As your original DOS 2.1 diskettes have no write notch on them, you can't run the program that repairs some of the glitches that came on these DOS disks. Remember, when you make copies of your original DOS disks, the copies you make need to be "patched."

If you have copies of DOS 2.1 that haven't been patched, or if you aren't sure if they have been patched, bring them to one of the Club meetings so they can be upgraded.

**SPEAKING OF PATCHES:**

One of our subscribers, Clyde Dodge, has been busy combing bulletin boards for patches that will allow you to make back-up copies of your software. All of us have had the frustration of trying to make a copy of one of our programs, but not being allowed to due to the program's copy protection scheme.

Most of us appreciate copyrights and licensing agreements. If we use Shareware we know that we can give friends copies of the programs. We know that we are violating the law if we give copies of commercial software to anyone. Still, there are valid times when we need to make copies of our commercial software.

Writing Assistant is a program that most Junior owners use. If we followed the instructions in the manual, we were able to make one copy. But some of us, like Clyde Dodge (and your editor), botched making our copy of Writing Assistant back in 1984. In fact, many people are still using their original, and only, copy of Writing Assistant. If we could make another copy it would be very beneficial. It would be like having insurance!

A few Junior users made their copies correctly back in '84 and then later, bought a new computer with a hard drive. Installing Writing Assistant to a hard drive is the same as making a copy, so now, when they want to use WA on their hard drive, they must place their original copy of WA in their disk drive before they can access Writing Assistant on their hard drive. If their copy of Writing Assistant wasn't copy protected, they could use this software on their new computer with no problem. Unfortunately, this isn't the case.


Well, this became a challenge to Clyde, and over the years, he has collected many patches that allow you to make back-up copies of much of your software, or allows you to make copies that are no longer copy protected. Most of these patches are DEBUG routines. What this means is that you must use DOS's DEBUG.EXE program. DEBUG allows individuals, who are knowledgeable on how programs work, to change programs, or to modify programs that have problems in them.

While most of the patches that Clyde has collected are relatively easy to use, it is beneficial if you are fairly experienced at using DEBUG routines. But, if you don't feel comfortable using DEBUG, Clyde will patch your programs for you.

Clyde wants to make sure you don't think that he is a computer wizard. He is like most of us in that he hasn't figured all these DEBUG routines out himself. They are the products of many people, and Clyde says that he has only collected most of the ones that Junior owners would be using. His collection now includes over 200 patches!

This really isn't an advertisement, but Clyde will send you his disk of patches if you want them for only \$4. This includes the disk, the mailer and postage! But, back to Writing Assistant--if you do not feel that you are up to doing the DEBUG routine yourself, you can send Clyde your WA disks and he will do it for you for only \$1 each.

## Modem News #2

Hi! Welcome again to the world of modeming. There are a lot of things you can do with Junior and a modem.

Just to start off the new year right, I took Louie's advice that he gave at the December meeting and went Christmas shopping for Junior. I bought Junior a new 2400 baud modem. . .and he loved it! He found that there were things he could do that he had only dreamed of doing. One of the things Junior found he could do was to upload AND download files. He is having such a good time sending and receiving files that I have to hold him back; he gets to be a real talker on the phone and if I don't slow him down he just keeps going to all hours of the night.

The modem that Junior got for Christmas is called *Quicktcl* and it was purchased at one of the local computer shops in the Valley River Center. It cost about \$80 and carries a lifetime warranty. It is 2400 baud and will automatically adjust to whatever baud rate that is on the BBS. The best part of a 2400 baud modem is that Junior spends less time on the phone so he can spend more time with the family.

This is going to be a great year to have a modem. I will try to give a list of the area's different BBSs and what they have to offer at the next meeting. We'll also talk about some of the different modems you can get for your Junior.

Remember, if you ever have any problems trying to get your modem doing what you feel it should do, we are here to help. Even if you are using a 128K Junior, one disk drive and a 300 baud Junior modem, we can help.

Evidently 300 baud means that the modem transmits 300 times faster than old J.M.E. could talk?


## TAX TIME AGAIN

If you're selecting software to prepare your 1991 taxes, the tax package on your dealer's shelf may be incomplete. As it takes software publishers time to incorporate the latest versions of the IRS's forms into their products, the release you find on retailers' shelves now can often be used only to *project* your 1991 taxes, not *file* them. To file your taxes, you'll need a final version of the software. This typically means sending in a registration card and waiting for a final version to arrive in the mail--which may not be until late February or early March.

To avoid buying an early edition inadvertently (since the packaging won't always tell you which version you're buying), ask the retailer if you're getting the final version--and ask to open the package in the store to be sure.

Finally, if you purchased tax software last year, check into the publisher's upgrade policy--you may be eligible to upgrade to this year's version for less than the cost of buying the software new.


