Nibble On This Byte

It is customary, when advertising a catalogue of products for sale, to charge a nominal fee for that catalogue which will then be deducted from the first purchase made from that catalogue. We've all seen this type of offer at work, indeed, most of us have taken part in this type of offer at one time or the other. Anyone who has a Sears or JC Penneys' catalogue in their home is very familiar with this routine. I have no problem with this means of advertising because I've requested the material, knowing up front that I will be charged. Recently, however, I've had occasion to become somewhat irritated at the advertising schemes of a well-known soft and hardware house for the Coco. Is my ire well-justified? Let me tell you the plain, simple facts and you be the Jury.

On March 16, 1987, the Postman delivered a packet with no return address to the "Coco Club of Elgin" c/o my home address. So far, no problem. As a past president of that user group, I continue to receive mail for the Club. After all, that is the address given in 'The Rainbow' as point of contact for the Club. (As recently as April 18, 1987, I've received mail for the Club from a Coco user in Argentina.) So, getting mail for the group is no big deal to set me on my high horse.

The packet contained the "Spring '87" catalogue of "Soft and Hard wares for colorful computing from ..."; a product review of one of the software products that they are marketing; and 100 (yes, I did count them) coupons for a \$2 discount at the door during Rainbowfest '87 held at the Chicagoland location. "Okay", you say, "Looks like a pretty good deal. Where's the beef?" Well, I'll tell you. Not one piece of literature in that packet was any different from this Company's ad in the above mentioned magazine. All this means is that they spent money for printing and distribution twice in order to be sure that I, and the Club, knew that they had something to sell. If they would have thought about it, the fact that our address was taken from the same place that their ads were reprinted from (e.i., the magazine) would have told them that they could have saved themselves some money. And I do admit that it seems real nice that they would agree to distribute those '\$2 off' coupons for "Rainbowfest". What I object so strongly to

is that I had to pay the Postman in order to get the packet in the first place. It seems that, with the inclusion of the coupons, the packet weighs between 3 and 4 ounces. Since there was only a \$.22 stamp on the packet it was incumbent upon me to fork over the remaining postage, especially since there WAS NO RETURN ADDRESS. (How conveniently forgotten.) Now, I know that this could've been an isolated incident, so I checked with another club's officer in the area. He, too, had received an identical packet WITH NO RETURN ADDRESS & WITH POSTAGE DUE. In short, it appears that the addresses were expected to pick up the tab for the agreement entered into by the merchandiser to distribute the coupons, WITHOUT THEIR KNOWLEDGE OR THEIR CONSENT, and very likely without the knowledge of 'The Rainbow', either.

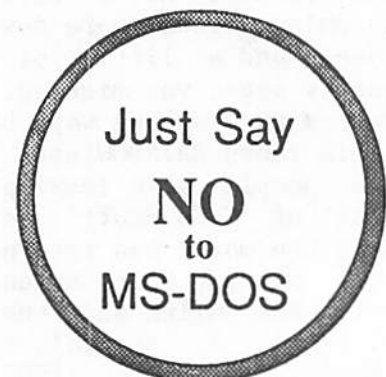
Although it is an excellent way to gain the good graces of Falsoft Publishing at a minimum of additional expense (at \$.51/copy, a mailing list of 200 would SAVE them over \$100 in postage if they sent the packets with postage due), this seems like a very poor way to build a good rapport with prospective customers and it certainly has left a sour taste in my mouth.

In spite of the desirability of the products that Bob Rosen and Spectrum Products market, it will be some time before I will consider them as a source for Mr. Coco's gregarious appetite for programs and hardware modifications.

I imagine any number of you are thinking that this is pretty small of me. Perhaps so, but if this is any indication of how Spectrum Products tries to win over new customers, just how do they treat those people who are their old customers? In my book, those who start out looking for ways to avoid responsibility (as they have in mailing items they KNEW were going to be postage due) will continue to attempt to dodge or deny other responsibilities that confront them.

Is my ire well-justified?

This year's fest was marked with the arrival of the CoCoIII and many new hardware and software items available for this fantastic machine. What was there for the CoCoII was not being discounted very much, if any discount at all. Most of the vendors stocked themselves with plenty of CoCoIII software and peripherals, and 'left' the CoCoII stuff at home. I remember asking one vendor, who shall remain nameless, if he had the Hardcopy (C) program for the DMP110 printer. He replied, "No, we can't bring everything we sell to the fests." Well one look around his booth would have explained everything. Considering the massive amount of wares he had brought with him, I would have been inclined to agree with him. Perhaps if he came in a Yugo, there might have been more room for him to bring 'all of his programs'. I had the pleasure of helping out Bob Rosen of Spectrum Projects for several hours Saturday and most of Sunday. A truly nice man to know, and a real credit to the CoCo community. He remained busy most of time. But I noticed that he quickly sold out of his hardware, far sooner than the software was sold. Still, not much of a discount there either, even though better than most other vendors.

Several people required monitor adapters, you know those little circuit boards which the CoCo III doesn't require. Good luck getting those. The few vendors who had them, quickly sold them, while others maintained their normal prices and took them home with them, must have driven a Yugo.

I asked another gentleman about lowering the price of his DWP 230 printer around fifty dollars. Making the price a mildly ridiculous two hundred dollars. "Huh...no way, we sold a lot of multi paks and other large items, we have room to take them back with us." Definitely had a large vehicle, possible an Escort.

I felt that this being my third fest in a row, perhaps I had gotten used to a finer selection. But alas no, when I put my prejudices aside and asked several friends that had just attended their first Rainbowfest this year, the reply was the same. "Where are the digitizers?" 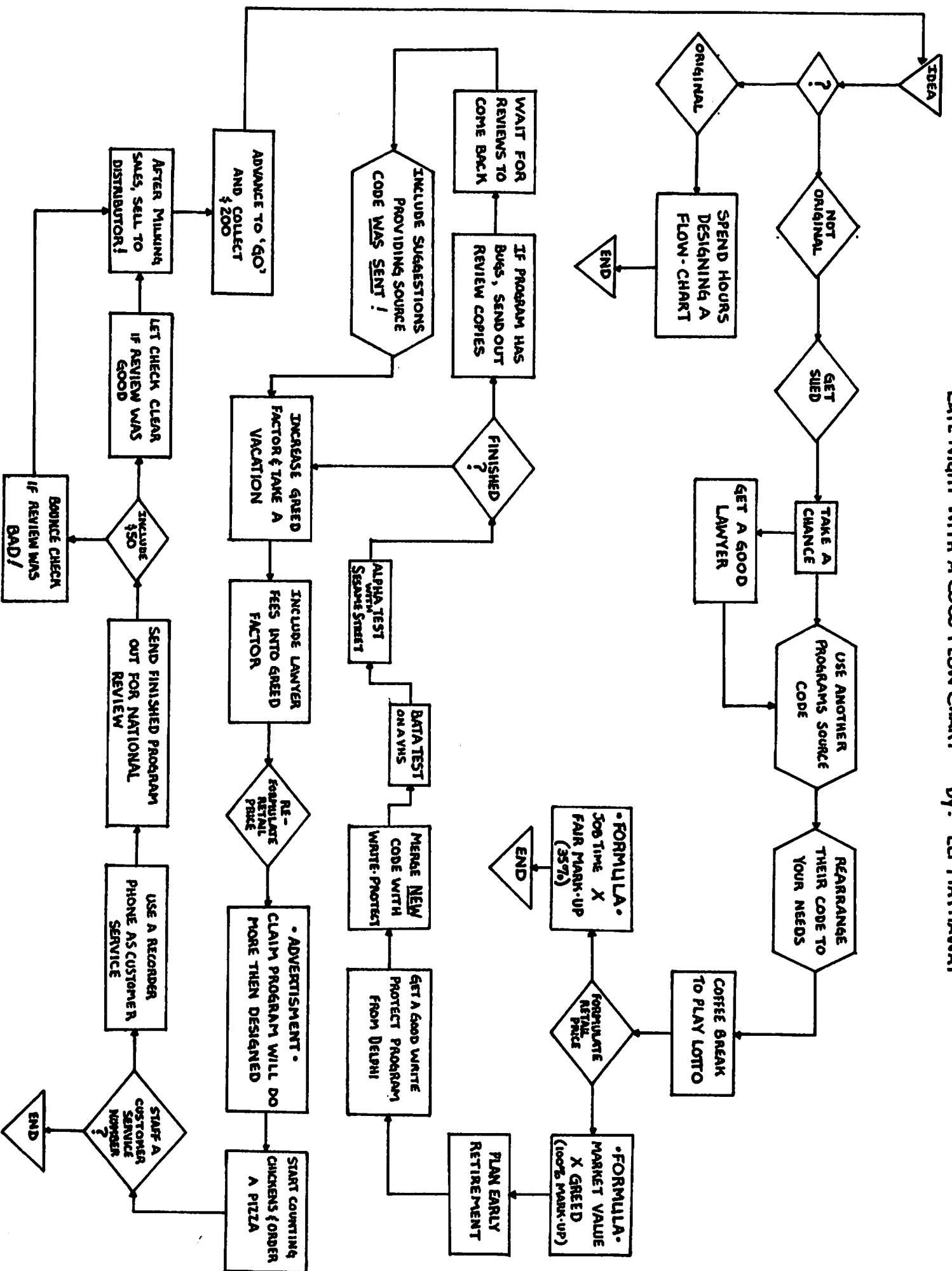

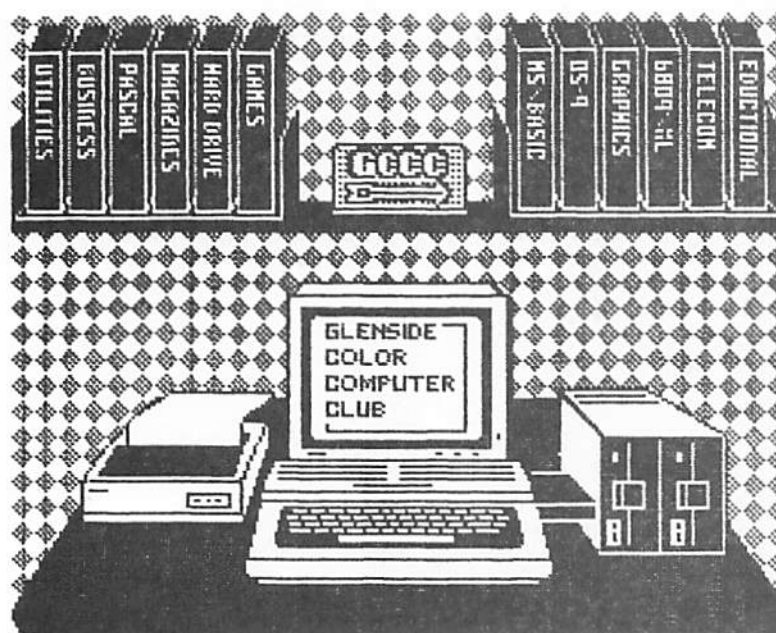
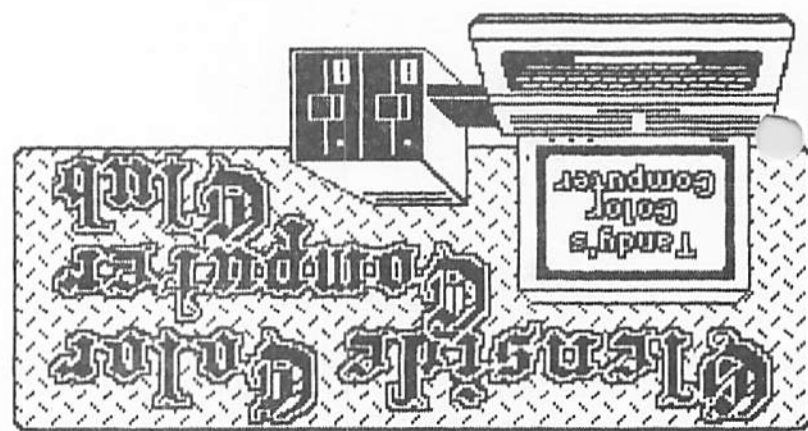
